## 2. Boards and committees vacancy

### A. Board of Adjustment (Attached NB-2A)

With the resignation of Robert Rollason, III, there is a regular member vacancy on the Board of Adjustment that will expire in October 2019. All applications on file from persons interested in serving have previously been copied to the Board of Commissioners and no new applications for those purposes have been received. Board of Adjustment alternate member, Jason Self, is interested in being considered for the regular member position. If the Board appoints Mr. Self to the regular term, then consideration may be given to appointing a person to fill the alternate position term, which will also expire in October 2019.

A motion will be in order to fill the vacant position on the Zoning Board of Adjustment for the remainder of a three-year term, and, if appropriate, the alternate position also for the remainder of a three-year term, both of which expire in October 2019.
