Thank you Kill Devil Hills for your continued support and partnership. The Community Care Clinic of Dare provides access to free primary medical care, medication assistance, and health and wellness education to low income, uninsured adults living or working in Dare County. We have served over 6,000 patients since inception in 2005. We currently provide services for over 600 people, with over 245 residing in Kill Devil Hills. We performed over 1100 laboratory services and provided over \$148,000.00 dollars in medication assistance, specialty referrals, and diabetic supplies to our patients. We are the only organization providing free primary medical care in Dare County, as the Dare County Department of Health only provides family planning, women's health, and infectious disease clinics. Many of our patients have chronic disease conditions which must be managed closely to insure compliance and healthy outcomes. The support Kill Devil Hills provides helps us continue our mission of providing quality primary medical care, medication assistance, and ancillary services to this very vulnerable population. CCCD has also been able to continue services via telemedicine during this COVID-19 outbreak. Continuity of care, and access to services has not been interrupted for our patients. Keeping our community, healthy and well benefits us all. Thank you again, for your continued support.

On behalf of Interfaith Community Outreach (ICO) Board of Directors, we extend our heartfelt appreciation for the continued partnership and financial support the Town of Kill Devil Hills has awarded to our non-profit. The mission of (ICO) is to provide assistance to individuals facing a temporary emergency crisis and our vision is "Bridging the Gap" where no one will face an emergency crisis alone. In 2019 ICO provided \$308,000 in direct services to our community. ICO helped 1,114 families of which 328 families received cancer outreach services. ICO volunteers logged in over 7000 hours and traveled 23,000 miles. In our 15 years of service to our community ICO has served over 7,500 families and the monetary outreach given back to our community is over \$3,522,253.

The \$10,000 partnership from the Town of Kill Devil Hills has been instrumental to ICO being able to provide emergency gap services to the working poor in our community.
