Michael Lowack's and Kevin Cox's terms as regular members of the Zoning Board of Adjustment expire May 2020, and Natalie Painter's alternate member term expires July 2020. All have expressed a desire to be considered for reappointment to another three-year term, and their appointment histories are included. No new applications have been received since they were last copied to the Board.

A motion(s) will be in order to make three three-year appointments, two regular and one alternate, to the Zoning Board of Adjustment for terms that will expire in May 2023 and July 2023, respectively.

B. Dangerous Animal Appeal Board

Sue Kelly's term as a member of the Dangerous Animal Appeals Board expires June 2020. She has expressed a desire to be considered for reappointment to another three-year term, and her appointment history is included. No new applications have been received since they were last copied to the Board.
