NOTICE OF WORKSESSION AND PUBLIC HEARING ON THE TOWN MANAGER'S RECOMMENDED BUDGET For Fiscal Year 2021/2022

NOTICE IS HEREBY GIVEN, in accordance with NCGS 159-12, on Monday, June 14, 2021 at 6:00 p.m. the Kill Devil Hills Board of Commissioners will hold a public hearing to receive public comment, both written and oral, regarding the Town Manager's Recommended Budget for Fiscal Year 2021/2022. Written comments, which will be included with the record of the public hearing on the Recommended Budget for Fiscal Year 2021/2022, may be submitted to the Town Clerk, P.O. Box 1719, Kill Devil Hills, NC 27948, or by e-mail to: odell@kdhnc.com. Comments must include your name and address and should be limited to three minutes when read aloud.

The Recommended Budget was presented to the Board of Commissioners on Monday, May 10, 2021. Significant elements of the Recommended Budget include, but are not limited to:

- For the Town of Kill Devil Hills, the Recommended Budget reflects the Town-wide tax rate of \$.32 per \$100 of real property; the additional tax rate applicable to real property listed within Kill Devil Hills' Beach Erosion Control and Flood and Hurricane Protection Works Municipal Service District (MSD), charged for the purpose of raising the revenue listed as "Taxes – Municipal Service District" is \$.24 per \$100 of real property.
- During the 2021/2022 Fiscal Year, the 2022 beach re-nourishment project is recommended to be financed by special obligation bonds, contributions from Dare County beach nourishment fund, ad valorem revenues. Other sources of revenues are grants from FEMA and NCDEQ.
- Retail water rates are recommended to increase 4% as the Town continues to address operating costs and waterline and system improvements that are associated with the Water System Master Plan. Tap fees are also proposed to increase based on cost of materials and installation.
- Funding in the amount of \$775,000 is included in the Street Capital Reserve Fund, and \$218,000 in Powell Bill revenues, for street/drainage improvements in several areas of Town; also part of this project will be associated waterline improvements, and \$100,000 in sidewalk improvements on West Third Street. Discretionary street maintenance and repair funding is continued in the amount of \$90,000.
- A 2.6% cost of living adjustment increase is recommended.
- Tipping fees for an estimated 11,675 tons of garbage at \$75.94 per ton, and 1,100 tons of construction and demolition debris at \$65.00 per ton.
- Fleet investments include: five police vehicles, a John Deere tractor backhoe, a Volvo Dump Truck, two residential garbage trucks and one commercial garbage truck.
- Debt service payments for the 2021/2022 Fiscal Year are included as follows:

- Recommended Lease Payments = \$1,227,619
- Debt Service – Public Works Complex = \$648,451
- Debt Service – Beach Nourishment = \$1,015,599

All citizens of the Town of Kill Devil Hills are invited and encouraged to attend the public hearing and make oral or written comments on the recommended use of funds.
