ANNUAL CERTIFICATION OF FIREFIGHTERS

*\*This form MUST be filled out and sent in for your Roster Renewal to be complete\**

North Carolina General Statute 58-86-25 requires that all certified fire departments submit a complete roster of its eligible firemen annually. This certified list determines eligibility for the \$100,000 line-of-duty death benefit as well as eligibility for Pension Fund credit. Failure to accurately and promptly report this information is violation of G.S. 58-86-25 and will automatically result in a loss or reduction of benefits.
